

**CIE Tours: Morris County St. Patrick's Parade Tour Giveaway**  
**March 2026**  
**Official Rules**

BY ENTERING (OR OTHERWISE PARTICIPATING IN) THE TOUR GIVEAWAY, ENTRANTS TO THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. 1. **ELIGIBILITY:** The CIE Tours Morris County St. Patrick's Parade Tour Giveaway is open only to individuals who are legal residents and physically located in one (1) of the fifty (50) United States or the District of Columbia, and Canada (excluding Quebec) and who are at least twenty-one (21) years of age or older as of time/date of entry. Employees, officers and directors of CIE Tours ("Sponsor"), and their respective parent companies, affiliates, subsidiaries, advertising, contest, fulfillment and marketing agencies, their immediate family members and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Tour Giveaway or win a prize. For purposes of this Tour Giveaway, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. By participating, you agree to these Official Rules and to the decisions of CIE Tours, which are final and binding in all respects. 2. **ENTRY PERIOD:** The Tour Giveaway begins on or about 9:00:00 AM Eastern Time on March 1, 2026, and all entries must be received by the Sponsor on or before 11:59:00 PM Eastern Time on March 20, 2026 (the "Entry Period"). The designated computer clock of CIE Tours is the official time-keeping device in the Tour Giveaway.
3. **HOW TO ENTER THE TOUR GIVEAWAY:** To enter the Tour Giveaway, during the Entry Period, you may visit the Tour Giveaway website at: <http://www.cietours.com/morrisparade>. The website contains a description of the Tour Giveaway and the official entry form. Entrants must complete and submit the entry form with all required information for the entry to be eligible.

First and last name, valid email address, and valid phone number are required to claim a prize. Winner is subject to verification by Sponsor, whose decisions are final and binding in all matters related to the Tour Giveaway. An entrant is not a winner of any prize unless and until entrant's eligibility has been verified and entrant has been notified that verification is complete.

4. **TOUR GIVEAWAY DRAWING/PRIZE CLAIMING:** There will be one (1) Prize winner selected in this Tour Giveaway. The potential winner will be selected through a random drawing on or about March 23, 2026, from all eligible entries received in accordance with these Official Rules. Sponsor will have complete

discretion over interpretation of the Official Rules, of administration of the Tour Giveaway, and of selection of the winner. Decisions of the Sponsor as to the selection of the winner will be final.

5. **ODDS:** Odds of winning a Tour Giveaway prize depend on the total number of eligible entries received.
6. **WINNER NOTIFICATION:** The potential prize winner will be notified using the information provided during entry by any of email, telephone, mail, a post on the potentially winning entry or through a direct message on a social media platform (if applicable) (method to be selected by Sponsor in its sole discretion) in a commercially reasonable time after the drawing. The Tour Giveaway Sponsor is not responsible for false, incorrect, changed, incomplete or illegible contact information. Notification is deemed to have occurred immediately upon sending of an email, placing of a phone call, one (1) day after sending via a delivery service or two (2) days after mailing. As part of the winner notification process, a potential prize winner may be required to complete and submit a prize redemption form ("Redemption Form") as a condition of receiving a prize. The prize is valid, and winner must book the travel by May 31, 2026, for travel dates before May 31, 2027, or prize will be forfeited in its entirety. Winner will not receive the difference between actual and approximate retail value. Airfare, any meals not included on the itinerary, passport, visa, insurance, and items of a personal nature are additional and the responsibility of winner (this list is illustrative and not a full list of items not included). In the event there is a discrepancy or inconsistency between disclosures and other statements contained in any Tour Giveaway materials and the terms and conditions of these Official Rules, these Official Rules shall prevail, govern, and control.
